Where We've Been

As we reflect on the accomplishments of the past two years, we are thrilled to share the remarkable progress toward our 2022-2023 goals at Housing Santa Cruz County. Your unwavering support has been instrumental in driving meaningful change, and together we have achieved significant milestones. With the strides we've made together thus far, we are excited to share some numbers that highlight the impact of our collective efforts at Housing Santa Cruz County (HSCC).

In the pursuit of affordable housing advocacy, we' sent over 100 letters to elected officials, and provided testimonies at over 20 policy hearings, engaging with decision makers to increase affordable housing opportunities and policy.

In late 2022 we pushed our "Housing is on the Ballot" campaign, an education and advocacy drive wherein we hosted candidate forums in North and South County, covering the different council, supervisorial, and state level candidates for office. We also collected candidate questionnaires and video messages geared towards affordable housing, and made those responses public via our website, newsletter, and social media.

During Affordable Housing Month 2023, (AHM), we hosted meaningful conversations with Dr. Tiffany Manuel, founder of TheCaseMade, and over 70 community leaders on the importance of changing the narratives and making a case for affordable housing and community partnerships. We heard from community leaders after these events how the perspectives Dr. Manuel shared will shape the direction of their annual work.

We also invited Shane Phillips, author of The Affordable City, to be the keynote speaker for the AHM kickoff event. His insights and vision for a more equitable housing landscape was well attended and received.

In addition to our special events, we led 14 additional AHM events that were hosted or co-hosted by community partners. We want to thank our staff, volunteers, and committed community for the tremendous, year-long commitment it takes to prepare for and successfully execute these 16 AHM events.

AHM 2023 built on progress made the prior year, which featured 13 events total, including events such as our "Housing for a Healthy Watsonville" forum and the and the "The Plan For More Affordable Housing: Influencing the Housing Element Process" housing forum.

Our signature event in 2022, "Affordable Housing Straight Talk: Local Leadership Tells Us How It's Delivering on Needs" was co-hosted with Lookout Santa Cruz and featured a "first person" report from each of the local government jurisdictions in Santa Cruz County featuring 4 City Mayors and the Chair of the County Board of Supervisors.

We are honored to be the lead organizer for Santa Cruz County's Affordable Housing Month and will continue to hold May as a pillar month for affordable housing advocacy, education, and progress.

2023 - 2025 Strategic Plan Goals

As we envision the year 2024, Housing Santa Cruz County (HSCC) stands committed to playing a major role in shaping the city revenue measure and fostering a future where affordable housing is accessible to all. Our multifaceted approach revolves around collaboration, education, advocacy, and community engagement. Some key goals for 2024 are:

1.) City of Santa Cruz Revenue Measure Engagement: HSCC will actively contribute to the development and success of a revenue measure in the City, recognizing its significance in creating real opportunity for Affordable housing initiatives and projects.

2.) Affordable Housing Month Expansion: Building on past successes, we will further expand Affordable Housing Month, bringing together hundreds of community members for education, advocacy, and engagement.

3.) Advocacy and support for Housing Projects: HSCC will continue to provide advocacy and support for ongoing and new housing projects, ensuring they align with our vision for a more inclusive and accessible housing landscape.

4.) Advocate for Policies: HSCC remains committed to advocating for impactful policies at the local and state levels.

5.) Partnerships with Local Organizations: Collaborating with other local organizations, HSCC will leverage collective strengths to amplify the impact of affordable housing.

6.) Representation of Underrepresented Communities: Recognizing the importance of diverse perspectives, HSCC will actively collaborate with underrepresented community members to ensure their voices are heard.

7.) Hosting Community Engagement Meetings: Hosting a series of community engagements. HSCC will facilitate open dialogues, ensuring community members have a platform to voice their ideas, concerns, etc.

8.) South County Housing Strategies: HSCC will work closely with partners in South County, tailoring housing strategies to address the unique needs of the region.

9.) Collaboration with City and County Leadership: Continue to strengthen partnerships with city and county leaders throughout Santa Cruz County to ensure our advocacy efforts align with the broader community goals and priorities, including Housing Element Commitments

10.) Support for Local Sales Tax Measures: Collaborating with the City and County, HSCC will extend support for local sales tax measures that contribute to funding and sustaining affordable housing initiatives.

Through relentless advocacy, we contributed to the approval of affordable housing units across multiple local jurisdictions.

These achievements are a testament to the dedication of our community and the meaningful change we can drive when we stand together. As we look ahead to 2024, we recognize the immense opportunities before us, from influencing Housing Elements to advocating for crucial revenue measures.


