I am excited to announce that I have joined Housing Santa Cruz County as the new Executive Director. I would like to take this opportunity to introduce myself.

I'm originally from the Bronx in New York City, and I've been a resident and community leader in Santa Cruz County for 21 years. From an early age, community, collaboration

and making a difference in my community led me to do the work that I do. I'm passionate about advocating for affordable housing, creating positive change in this community, wanting the playing field to be leveled for everyone to have a seat at the table, and for there to be no limits regardless of race or background. I believe there is nothing one cannot do if they are given the space, time, and support (financial and emotional) to do it. I hold a bachelor's degree in political science, a juris doctorate from Monterey College of Law, and am a certified mediator. ### Housing is on the Ballot Event Recaps



HSCC co-hosted a ballot measure forum in Watsonville on October 19 and heard from representatives of two competing measures – Measure Q and Measure S. There are significant similarities between the measures in that they both would sustain the current urban growth boundaries of the City of

Watsonville. The main difference is that Measure S is more permissive in allowing some modification of the boundary under certain circumstances.

The primary takeaway from this discussion was very heartening to those of us who are continuing to seek more affordable housing across our county. That takeaway: both teams very much support higher-density infill housing in downtown Watsonville and in other under-used commercial areas within the current city limits. This is the housing we need—and it represents truly sustainable development that protects open space and reduces transportation impacts. We'll be working with both teams in the years ahead.

HSCC also co-hosted a Candidates forum in collaboration with the UC Santa Cruz Division of Student Affairs & Success, Graduate Division, Sociology Department, UCSC Graduate Student Association, Student Union Assembly, The Student Housing Coalition, Monterey Bay Economic Partnership, and the UCSC College Democrats.

The forum included County Supervisor candidates Justin Cummings and Shebreh Kalantari Johnson, Santa Cruz Mayoral candidates Fred Keeley and Joy Schendledecker, and City Council District 4 candidates Gregory Hyver, Hector Marin, and Scott Newsome. The forum was very informational for both UC Santa Cruz students and the general public. We are working on acquiring the recording of this event and hope to share it asap!
