Housing Santa Cruz County Celebrates Successful Launch!

HSCC would like to thank the many organizations and community members who helped make our official launch a huge success. A total of **148** people attended the virtual event and **\$19,400** was raised during the launch week! If you missed it, view live stream video on our <u>Facebook page</u>.

The kick off event featured California State Controller Betty Yee as the keynote speaker who spoke about the need for permanent housing for all California residents including necessary social support services. Gloria Bruce from East Bay Housing Organization in Alameda County enthusiastically expressed support for HSCC and shared tips from her own experience on how to successfully move forward. In a moving video at the start of the event, Diana Alfaro from MidPen Housing said "we dream of a time when affordable housing is no longer a talking point in election campaigns". Fred Keeley, Don Lane, and Diana Alfaro responded

to questions from attendees about the new organization. Answers to questions that panelists were not able to respond to due to time constraints will be posted to the HSCC website.

Projects in the Pipeline

Each month we'll provide updates on affordable projects that are moving forward in various jurisdictions across our county. Here are some examples and there are more to come!

City of Santa Cruz

Pacific Station North

This proposed mixed-use project would include 100% affordable housing with retail/office space on the ground floor. The City anticipates that there will be up to 100 affordable rental apartments for households with incomes ranging from 30 - 60% of Area Medium Income (AMI), including a minimum of 25% permanent supportive housing units. The City will continue to own the land and ground lease the various components of the mixed-use development.

City of Watsonville

1482 Freedom Boulevard

On February 23rd, the Watsonville City Council approved Eden Housing's density bonus and design review permit application to allow construction of a 53-unit affordable housing project located at 1482 Freedom Boulevard. The project proposes to build new affordable housing within two three-story buildings with 11 one-bedroom, 26 two-bedroom and 14 three-bedroom units. The City of Watsonville is one of 213 jurisdictions that have not made sufficient progress toward their Regional Housing Needs Assessment (RHNA) allocation for lower income households and therefore is subject to the streamlined ministerial approval process for projects with at least 50 percent affordable units per SB 35. The project is consistent with objective development standards with approval of requested concessions and waivers per State Density Bonus law and will help accomplish the City's Housing Element goals.

City of Scotts Valley

The Terrace at Scotts Valley Planned Development is currently under construction on Scotts Valley Drive (cross street Mt. Hermon Road). The project includes 19 three-bedroom, 2.5 bath single-family attached homes, with one low-income and one moderate-income affordable housing units.

News Around the County

Santa Cruz City Receives State Funding for Affordable Housing

The City of Santa Cruz recently received \$5 million of state funding for affordable housing from the Local Housing Trust Fund, a grant program of Housing and Community Development. Funding provided by the state is allocated for affordable housing on a price matching basis and the City plans to use land assets to meet the match requirement.

Scotts Valley Considers Expanding Inclusionary Program Boundaries

In an effort to address the critical need for workforce housing, the City Council's Affordable Housing Subcommittee has discussed expanding the inclusionary program boundaries as

well as stepping up promotion of ADUs. Committee members also discussed creating a formula to help developers better understand the city's affordable housing requirements.

Santa Cruz County Board of Supervisors Consider Tiny Home Ordinance

In response to the county's housing crisis, the Board of Supervisors is exploring smaller alternative housing options including tiny homes. The County Planning Department is drafting an ordinance allowing tiny homes as primary or accessory dwelling units.
