Steps Up Advocacy Efforts

HSCC will begin taking positions on key affordable housing issues and policies <u>targeting our</u> <u>most vulnerable residents and working families and individuals who are below the County's</u> <u>median income</u>. Projects must be located in Santa Cruz County and policy proposals must have a direct link to affordable housing creation or preservation for residents and workers in Santa Cruz County. HSCC may also advocate for mixed use projects that include more than the minimum requirement for low-income units and projects that will help jurisdictions meet RHNA allocations for below market rate housing.

HSCC has a particular interest in the following:

- 100% affordable projects for extremely low, very low, low and moderate-income households.
- Projects focused on vulnerable populations such as seniors, farmworkers, persons with disabilities and individuals exiting homelessness
- Efforts that increase the amount of funding for new housing units for low, very low and extremely low-income households
- Workforce housing projects with some affordability and local preference requirements
- Projects that take maximum advantage of job centers and transportation corridors

If you or your organization is interested in submitting a request for support or endorsement, the form to complete as well as our timeline for processing requests can be found on our website. Please carefully review the principles and criteria that will guide our decisions before submitting a request.

First Endorsements & Project Support!

ACA-1 (Aguiar-Curry)

This bill would lower the threshold for passing bonds (housing and infrastructure) from 66% to 55%, similar to school bonds. HSCC endorses this critically important bill as it will help us secure more funding for affordable housing. With passage in the State Legislature it would be placed on a statewide ballot for voter approval. Contact: a04.asmdc.org

AB 1401 (Friedman)

This bill in the state legislature would reduce parking requirements for projects on transportation corridors. HSCC endorses AB 1401 because reducing parking requirements could significantly reduce the cost of producing affordable housing units. Contact: a43.asmdc.org

Cedar Street Affordable Housing Project

HSCC supports the Pacific Union Partners' downtown Santa Cruz project. The 65-unit 100% affordable rental project will serve very low and low- income residents, some homeless veterans, and supportive housing tenants. This project does not reach the maximum allowed density. Because appropriate sites for housing are few and the need for affordable housing is great, we encourage the developer to consider options that would increase the density and the number of rental units.

Housing Element Progress Reports

How Do We Measure Up?

The Housing Element (HE) is a required part of a jurisdiction's General Plan that addresses how the housing needs for its residents will be met. The Regional Housing Needs Allocation

(RHNA) in the HE quantifies the housing needs by income levels for a specified planning period. The current HE covers the period of time from 2015- 2023. State law requires all jurisdictions to provide a HE annual progress report on efforts to achieve Regional Housing Needs Allocation (RHNA) goals. Here's how our local jurisdictions measured up!

(The units to date below cover the period of time from 2015 through 2020.)




